

FAREPAY.RIDEUTA.COM WEBSITE TERMS OF USE

READ THESE TERMS OF USE CAREFULLY BEFORE USING THIS SITE.

By accessing the web site located at farepay.rideuta.com (collectively referred to as the "Site"), printing or downloading materials from the Site, or otherwise using the Site, you ("you", "your" or "user") agree that you have read and agree to the farepay.rideuta.com Privacy Policy applicable to this Site and the terms and conditions set forth below, as the same may be amended or modified from time to time (collectively, the "Terms"). "Card" means, individually and collectively, each stored value card offered for sale through the Site.

This Site is intended for and applicable only for residents of the United States. If you are from another jurisdiction, you may not use this Site.
