

FAREPAY.RIDEUTA.COM WEBSITE TERMS OF USE

READ THESE TERMS OF USE CAREFULLY BEFORE USING THIS SITE.

By accessing the web site located at farepay.rideuta.com (collectively referred to as the "Site"), printing or downloading materials from the Site, or otherwise using the Site, you ("you", "your" or "user") agree that you have read and agree to the farepay.rideuta.com [Privacy Policy](#) applicable to this Site and the terms and conditions set forth below, as the same may be amended or modified from time to time (collectively, the "Terms"). "Card" means, individually and collectively, each stored value card offered for sale through the Site.

The Site, and any data, public, personal, or otherwise, transmitted via this Site is owned by the Utah Transit Authority ("UTA"). Interactive Communications International, Inc. ("InComm") maintains and/or arranges for the maintenance of and storage of data on this Site, manages FAREPAY accounts, and processes financial transactions. UTA and InComm and/or its parent company, affiliates, subsidiaries, and/or their respective suppliers and licensors, are individually and collectively referred to herein as "we", "us" or "our."

This Site is intended for and applicable only for residents of the United States. If you are from another jurisdiction, you may not use this Site. By accessing this Site in any way, including, without limitation, browsing this Site, using any information, and/or submitting information, you agree to and are bound by the Terms, including, but not limited to, conducting this transaction electronically, disclaimers of warranties, damage and remedy exclusions and limitations, and a choice of Utah law.

From time to time we may update this Site and these Terms. Your use of this Site after we post any changes to these Terms constitutes your agreement to those changes. You agree to review these Terms periodically to ensure that you are familiar with the most recent version. We may, in our sole discretion, and at any time, discontinue this Site or any part thereof, with or without notice, or may prevent your use of this Site with or without notice to you.
